Regular Meeting Minutes
November 10, 2020

<p>1. Call to Order and Roll Call Vote</p>	<p>President Wallender convened a public meeting of the Board of Directors at 12:06PM. The meeting was held via phone and video chat in compliance with Executive Order 20-16.</p> <p>Directors Present: President Tim Wallender, Vice President Tanner Sheahan, Director Nathan Smutz.</p> <p>Staff Present: Executive Director Alex McHaddad, Office Assistant Curtis Carson, Ms. Margo Schlessler (Payroll & Accounting Services), Mr. Rob Stilson (RS Technology).</p> <p>Members of the Public: N/A.</p>
<p>2. Declaration of Conflict of Interest</p>	<p>Asked and none declared.</p>
<p>3.a. Director Report & Vice Chair Election</p>	<p>President Wallender claimed that he was not allowed to provide input to edit or make additions to the meeting agenda. He recommends that new Directors receive training on public meeting laws and board member duties through the District's legal counsel or SDAO.</p>
<p>3.b. Staff Report</p>	<p>Executive Director McHaddad announced that channel 16-4 will begin over the air testing on Thursday and likely go live the following week. Curtis Carson has been doing excellent work assisting in the office. The Executive Director will meet with the audit team following the Board meeting. Mr. Carson's work was commended. They are discussing how to navigate office work during the Governor's forthcoming "Two Week Pause" order, but office work will likely continue.</p> <p>There is now a spare transmitter at the Beaver</p>

	<p>Mtn. facility. He reviewed costs for installing a new emergency alert receiver, including \$7,778.00 for a DASDEC EAS device and some additional equipment and time. (Stilson)</p> <p>The 2020-2021 Budget will not accommodate purchasing and installing a new EAS system, and the District should wait until 2021 to move forward. (McHaddad)</p> <p>Directors received the YTD through October financial report. Some power reimbursement payments have fallen behind due to COVID-19-related work restrictions at power user payment contractors based in New York. (Schlessler, Wallender, McHaddad)</p> <p>Sick pay was briefly discussed prior to the dedicated agenda item.</p>
<p>4.a. HR Complaint</p>	<p>Vice President Sheahan announced that a document summarizing HR dispute resolution services through SDAO had been delivered to all Directors. The document was summarized. In order to further involve SDAO in HR dispute resolution, the Board must meet with SDAO and counsel in the future. A dispute resolution process with SDAO will likely require the appropriation of \$2,500.00.</p> <p>President Wallender mentioned contact with legal counsel and encouraged all new Board Members to receive training from SDAO. All Board members should be present at a Board meeting where HR complaints are discussed. He alleged that illegal proceedings took place at the previous Board meeting, and this should be the focus of the Board. He then claimed that all members of the Board do not need to be present at a meeting SDAO and legal counsel. Vice President Sheahan is encouraged to review public meeting procedures with SDAO or legal counsel.</p>

SDAO has recommended meeting with the Board and the District's general counsel to discuss HR complaint resolution procedures. President Wallender was asked how he would prefer to move forward following the SDAO recommendation. (Sheahan)

President Wallender wants to move forward by having new Directors receive training on public meeting procedures. Any correspondence with SDAO was labeled hearsay. A written request to meet with the Board to discuss HR complaint resolution procedures should be provided to the Board. The report from SDAO was not delivered with adequate time for action to be taken. (Wallender)

Vice President Sheahan was not able to complete the report at an earlier time due to personal time constraints. President Wallender believes that no action should be taken until correspondence with SDAO regarding HR complaint services is reviewed by the full Board and legal counsel.

President Wallender suggested tabling the item.

Vice President Sheahan asked when the President prefers to take action on recommended actions from SDAO. President Wallender does not want the Board to take action until recommendations are reviewed by the full Board and the District's legal counsel.

Executive Director McHaddad raised a point of order as parliamentarian that a motion had been made without a second. A Director may second the current motion, and if it fails, another Director may make a different motion.

President Wallender moved to table the discussion, without a second. *Motion fails.*

Vice President Sheahan moved to hold a meeting with SDAO and the District's legal counsel, without a second. *Motion fails.*

President Wallender asked if this meeting would occur after legal counsel reviews documentation; he wishes to review documentation from SDAO. Vice President Sheahan reiterated that SDAO is requesting a meeting. President Wallender claimed that the written request from SDAO was written by Vice President Sheahan, and that a written report from SDAO should be provided.

Vice President Sheahan reviewed a document sent to the Board members about contact with SDAO authorized by the Board of Directors, and written correspondence from SDAO regarding complaint resolution procedures.

President Wallender interrupted Vice President Sheahan and expressed that the agenda item was to hear a report, then claimed that the agenda item did not include taking action. He claimed that legal counsel was not privy to correspondence from SDAO reported by Vice President Sheahan. No action should be taken without the full Board of Directors present. Written correspondence needs to be submitted by SDAO.

Vice President Sheahan claimed that absent Board members had previously clarified that they were unavailable at the date and time set by the President. He would like to see a report from Director Wood about her experiences and observations as a Director. President Wallender claimed that SDAO would be responsible for determining input from Directors.

President Wallender expressed dissatisfaction

	<p>with the complaint resolution process and that procedures are unorganized. He claimed that Vice President Sheahan's report only included notes from conversations with SDAO, and Directors and legal counsel should receive written correspondence from SDAO.</p> <p>Vice President Sheahan reiterated that he had motioned to hold a meeting with SDAO and the District's legal counsel.</p> <p>Executive Director McHaddad raised a point of order as parliamentarian that a motion had been made and a second had not been received; a second must be made by President Wallender or Director Smutz. He repeated the motion. Director Smutz asked if receiving a written request for a meeting from SDAO would address President Wallender's concerns. President Wallender verified that this would address concerns, along with an understanding that the full Board should be present for discussion. President Wallender then expressed that he objects to the consideration of the motion, and believes that public meeting laws were possibly being violated.</p> <p>Vice President Sheahan asked if public meeting laws were violated by motioning that the Board hold a meeting with SDAO and general counsel. Executive Director McHaddad noted that public notice about the current item had been provided. Oregon public meeting law allows agenda items to be added the day of a meeting, however, the meeting materials clearly stated that a report would be received and that the Board would consider taking action based on the report. Clarification from Vice President Shahean was then requested on whether his report included written correspondence from SDAO.</p> <p>Vice President Sheahan clarified that SDAO had provided written requests for a public</p>

meeting. Written correspondence from SDAO has already been reviewed by the District's legal counsel.

Director Smutz asked the motion could be amended to make a meeting with SDAO contingent upon receiving a written request for a meeting from SDAO. Executive Director McHaddad made a determination as parliamentarian that Vice President Sheahan's motion would have to be withdrawn, then a new motion would be made. Vice President Sheahan withdrew his motion when a second was not received.

Vice President Sheahan moved to schedule a meeting with SDAO and the District's legal counsel and the Board in its entirety pending a written request from SDAO, second by Director Smutz.

Discussion:

- President Wallender wants correspondence from SDAO to be provided to legal counsel. Vice President Sheahan clarified that legal counsel had been privy to most written correspondence from SDAO.
- Director Smutz is uncomfortable with taking action without the full Board present. He asked if President Wallender is satisfied with the direction.
- President Wallender is not satisfied and claims that the process is suspicious, especially since the Vice President's written report was not delivered prior to the Board meeting, and he is unaware of when other Board members received the report.
- Vice President Sheahan expressed that the President seemed to be making an accusation, and reminded the Board that the report was sent in writing to all Directors at the beginning of the

He asked whether the President was formally accusing him of delivering the correspondence to other Directors early.</p> <ul style="list-style-type: none"> ● President Wallender believes that the Board did not have adequate time to review the report. ● Director Smutz verified that the President was included in the email that contained Vice President Sheahan's report. ● President Wallender expressed that Directors were not given adequate to review the report and take action. ● President Wallender called the question. ● President Wallender claimed that the President only casts a tie-breaking vote. Executive Director McHaddad clarified that this was true earlier in District history, but that was removed from the Bylaws. <p>YES: Vice President Sheahan, Director Smutz. NO: N/A. ABSTAIN: President Wallender. <i>Motion passes.</i></p> <p>Vice President Sheahan will solicit a written document from SDAO. Executive Director McHaddad will coordinate the schedule. authorization to write a Paid Time Office policy with the help of Payroll & Accounting Services, PC.

Public comment received from Mr. Rob Stilson noted that benefits for part-time employees is uncommon. It also seems like a conflict of interest for the Executive Director to write a policy that benefits himself. Ms. Schlessler noted that among 70 companies that her firm serves, sick leave is only provided to part-time employees on rare occasions as per state law, usually due to the importance to the employee.

President Wallender asked if the District could create an HSA, or if there are any other options that do not involve paperwork.

Ms. Schlessler believes the existing policy needs to be changed. An HSA would replace insurance. A bonus could be given at the beginning of the year to pay for time off later in the year. The definition of full-time must be addressed, as it is currently 30 hours.

Vice President Sheahan expressed that the policy specifically serves the District's manager, not just a lower level employee like a custodian. The employee handbook states that employees are the District's greatest asset.

President Wallender noted that there is a historical process that has led to the current Executive Director's job description and workload. The handbook should be updated.

Ms. Schlessler noted that the employee handbook was written in 2016 and is in serious need of being updated.

President Wallender called a recess at 1:25PM. President Wallender ended the recess at 1:30PM.
