December 8, 2020

1. Call to Order and Roll Call Vote	<p>President Wallender convened a public meeting of the Board of Directors at 6:00PM. The meeting was held via phone and video chat in compliance with Executive Order 20-16.</p> <p>Directors Present: President Tim Wallender, Vice President Tanner Sheahan, Director Nathan Smutz.</p> <p>Staff Present: Executive Director Alex McHaddad, Office Assistant Curtis Carson, Ms. Margo Schlessler (Payroll & Accounting Services), Mr. Rob Stilson (RS Technology).</p> <p>Members of the Public: Mr. John Cavin.</p>
2. Declaration of Conflict of Interest	Asked and none declared.
3.a. Director Report	Asked and none received.
3.b. Staff Report	<p>Management is cooperating with the audit process authorized by the Board. Blue Mountains Now began broadcasting over-the-air on November 16. SDAO provided a grant for the office surveillance system. (McHaddad)</p> <p>Oregon Public Broadcasting is not paying power bills, resulting in lower power reimbursement income compared to this time last year. (Schlessler)</p> <p>OPB power billing procedures were summarized. (McHaddad and Wallender)</p> <p>Installation of an office surveillance system is on hold until contact is made with Union County to verify that installation may occur. (Stilson)</p>

4.a. Safety	President Wallender asked if the Executive Director is maintaining a safe work environment. Executive Director McHaddad is doing his best despite the circumstances.
4.b. Contract Review Board	<p>President Wallender opened a public hearing of the Contract Review Board at 6:48PM.</p> <p>Executive Director McHaddad reviewed the item as summarized in the Board Packet.</p> <p>Mr. John Cavin, owner of Cavin Wireless and subsidiary Oregon Wireless, discussed the existing relationship with BMTD and desires for potential contract changes. He noted concerns that the District had not been diligently monitoring contracts. A five-year contract is needed for financial reasons. Directors commented on Mr. Cavin's remarks, verified the lack of diligence, and briefly discussed a 3-year term for a contract</p> <p>Executive Director McHaddad will negotiate the renewal of the contract effective January 1, likely retroactive from the date of signature, with a term of 5 years from that date and monthly rent of \$400.00. Changes will be submitted by BMTD and Cavin Wireless, and the draft contract will be reviewed by BMTD's legal counsel prior to approval by the Board.</p> <p>No members of the public were present to make a comment. President Wallender closed a public hearing of the Contract Review Board at 7:18PM.</p>
4.c. HR Complaint	Executive Director McHaddad reviewed the item as summarized in the Board Packet. President Wallender invited Mr. Wyatt Baum to offer legal advice to the District.

Mr. Baum briefly summarized his contact with Spencer Rockwell at the Special Districts Association of Oregon. It is advised that BMTD contracts with HR Answers for conduct investigations as facilitated by SDAO. No more back channel discussions need to occur. It is advised that no District official comment publicly on an existing HR matters.

Directors and counsel discussed the engagement of legal services by the District's attorney. Existing arrangements allow for the Board's presiding officer to review legal problems with counsel, and for the counsel to take action to protect the District from potential legal issues as a fiduciary responsibility. However, because his firm's services were engaged without the knowledge of the Board, \$600 from the fee for meeting with the President will be waived.

President Wallender claimed that public meeting laws were violated at an October meeting of the Board of Directors. He asked if counsel can verify quorum requirements for the Board of Directors. Mr. Baum noted that the Board bylaws require a quorum of at least 3 Directors but all motions must be approved by at least 3 Directors to be valid. President Wallender noted that a motion made at the previous meeting to invite counsel to discuss HR complaints was made at a meeting with only 3 Directors, and he abstained.

Executive Director McHaddad discussed the President's repeated claims of public meeting law violations, which are based on a legal opinion exempt from public inspection. He noted that he believes that the opinion is erroneous, but he does not have the consent of

<p>5.b. Meeting Minutes</p>	<p>Directors were asked if minutes were reviewed. (Wallender) President Wallender requested that the minutes be amended to say that he claimed quorum rules were violated rather than public meeting laws. Executive Director McHaddad noted that this cannot be amended because during the November meeting, President Wallender claimed that public meeting laws had been violated, not that quorum rules had been violated, and the minutes must reflect what was discussed. A remark by Ms. Margo Schlessler regarding the rarity of paid sick time for employees was corrected. A reference to remarks made by President Wallender but erroneously attributed to Vice President Sheahan was corrected.</p> <p>Director Wood moved to approve the minutes as amended, second by President Wallender. <p>5.c. Supplemental Budget</p>	<p>Executive Director McHaddad reviewed the item as summarized in the Board Packet.</p> <p>The approval process for an audit was discussed. The last discussion took place at the beginning of the year. Executive Director McHaddad recalled that discussions had stalled at performing an agreed-upon services examination of past finances with a contract auditor to investigate potential fraud and</p>

There was no directive to conduct an audit of the 2019-2020 fiscal year, and a report in lieu of audit was prepared because the District did not spend more than \$150,000.00. President Wallender, and Directors Butner and Wood, recalled additional conversations about wanting an examination of the District's financial health. Executive Director McHaddad noted that the budget is prepared beginning in April every year, and that is the time when Directors need to contribute their funding priorities to the budget writing process, and no member of the Board asked for the 2020-2021 fiscal year budget to include funding for an audit of the 2019-2020 fiscal year.</p> <p>The Executive Director and Ms. Margo Schlessler will draft a supplemental budget and present it to the Board in January.</p>
